#### **Note:**

1. Reservation shall be provided to SC/ST/BC candidates as per reservation policy of Government of India. The candidates belonging to BC must submit their caste certificate issued recently (Not before 6 months form the date of submission of application and date of interview also, if called) for the purpose of non – creamy layer.

**Age-** Candidates should not have attained the age of 35 years on the closing date for receipt of application SMS (Animal Husbandry) and 25 year for Supporting Staff (Farm Attendant). Age relaxation will be provided to SC/ST/BC candidates as per the policy of Government of India as amended from time to time.

#### **Application Fee –**

### **GENERAL NOTE**

1. The application form in MS Word format should be downloaded from the KVK website and only the typed copies of the application should be submitted. The application form available for download from the website is only a Proforma and the applicants are advised to retype it leaving at least 1.5 inches' margins on both sides of the paper and using at least 12 point 'Time New Roman' font. If the space provided in any column is found insufficient, information may be provided on a separate sheet indicating the enclosure number at the suitable place.
2. The candidates will have to produce the original copies of all certificates and documents attached at the time of interview for verification.
3. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issue of appointment letter, the SURE reserves the right to modify/withdraw/cancel any communication made to the candidates.
4. Those already employed should apply through proper channel or submit No Objection Certificate issued from the Employer. However, they may submit an advance copy to meet the deadline set for receiving the application.
5. Any type of convincing or influencing will be treated as disqualification. Posts of Subject Matter Specialists & Supporting Staff (Farm Attendant) are ICAR Plan (100 %) in KVK's and will be filled only up to the project period and after completion of the project posts will be abolished and services of the selected person will be immediately discontinued from the SURE services without any notice period.
6. A candidate, who knowingly or willfully furnishes incorrect or false particulars or suppresses material information, will be disqualified and, if appointed, will be liable to dismissal from service without prior notice.
7. No candidate shall be eligible for the appointment to the service who has more than two children on or after 1.6.2002 (as per Government of Rajasthan rules as amended from time to time).
